

Approved By-Laws of the Bundaberg Sailing Club

1. All proposed **By-laws** be displayed on the club notice board for one month to elicit comment from members prior to adoption by the Management Committee. All comments to be in writing. (App 4-7-2001)
2. **Club Access:** That all areas of the clubhouse and verandah, except the office and providore's store, be available to all members and guests at all times, provided that the Caretaker or a member of the Management Committee is on site and that the clubhouse is not hired out to groups or individuals, and... That the BBQ and verandah areas be available to all members and guests at all times except when the clubhouse is hired out to groups or individuals. (App 4-7-01)
3. **Boat Storage:** As per the Storage of Boats Policy approved 1st October 2013. All financial, full members of the club may store their boat for one week in any financial year free of charge. (App 4-7-2001)
4. **Use of Pontoon:** As per the Pontoon Use Policy approved 1st October 2013.
5. **Deployment of Safety/Rescue Boats** shall be in accordance with the Policy approved 1st October 2013.
6. **Disposal of Club Property:** shall be by:
 - a. Trade-in or condemning by the management committee
 - b. Calling tenders from club members
 - c. Calling for public tenders as determined from time to time by the management committee. (App 4-7-2001)
7. **Sail Training**
 - 7.1 That all persons undertaking a sail or boat training course at the club must be a financial member of the club or pay a fee prescribed by the management committee, and
 - 7.2 That all YQ boat training programs will be carried out by accredited persons appointed by the club, and
 - 7.3 That clause 2, in no way prevents individual classes or divisions from organizing their own training programs and appointing their own class/division trainers provided clause 6.1 is upheld. Use of club boats and facilities must be approved by the Vice Commodore. (App 1-8-2001)
 - 7.4 That all "Learn to Sail Programs" approved by the club must use boats owned by the club. Owners of private boats offering to use their boats for club training must indicate to the club in writing that they accept responsibility for both personal and property liability and have the appropriate current insurance cover. (App 16-1-2002)
8. **Commercial Training**
 - 8.1 That any person wishing to engage in commercial sail or boat training at the club must apply to the management committee seeking approval, setting out the details of the program and confirming that they carry the appropriate insurance cover. This by-law does not prevent any financial member from engaging a private tutor.
- 8.2 The management committee will negotiate arrangements with schools outside of items 1 to 2 who wish to promote their own sailing program and use the club facilities. (App. 1-8-2001)
9. **Dogs:** that all dogs are banned from entering club buildings and that all dogs on club grounds must be on a short leash and under the control of the owner. Any dog causing problems to members or the caretaker will be removed. (App 1-8-2001)
10. **Use of facilities** other than for organized club activities:
 - 10.1 **Living on boats, camping in tents or caravans,** within BSC grounds, must have prior approval of the management committee. In emergency situations the approval of one member of the management committee is sufficient until the issue can be determined by the full management committee. The management committee reserves the right to determine conditions and charges for use of facilities on a case by case basis.
 - 10.2 **Living on boats at anchor:** The use of club facilities in this situation must have prior approval of the management committee. In emergency situations the approval of one member of the management committee is sufficient until the issue can be determined by the full management committee.
 - 10.3 The BSC reserves the right to charge fees to members for excessive use of facilities, outside of club organised activities. More than four weeks usage in any one membership year will be regarded as excessive.
 - 10.4 The taking of **potable water** from the club rain water tanks is subject to availability as may be determined by the caretaker in emergency situations, or otherwise by the management committee. A fee may be charged if considered appropriate. (App 14-12-2010) (reviewed 1st October 2013)
11. **Membership.**
 - 11.1 Family membership as set out in Clause 5(1)(b) of the Club's Constitution is to include all adults as defined by family law legislation i.e. Two adults living in a committed exclusive family relationship, and their respective children under 18 years of age.
 - 11.2 Membership fees. Person or persons joining between 1st of July and 31 December pay the full years Membership. Persons or persons joining between 1st of January and 30 June pay 6 months membership. (App 20-05-17)
